Thomas Mann, Sr., and Elizabeth (probably Booth) Timeline

- abt 1626 **Probably England**. **Thomas Mann**, the immigrant, was born. Although William Marion Mann, Jr., in his chapter, "Descendants of Thomas and Elizabeth Mann of Isle of Wight," speculated that Thomas Mann/Man was from a Mann family in County Kent, a check of available birth records for this name in England at www.ancestry.com produced a number of Thomas Manns.¹
- abt 1648 Nansemond Co., VA. Thomas Mann emigrated to Virginia and apparently lived here.²
- 22 Mar 1650 **Nansemond Co., VA. John Garwood** was granted 1,000 acres of land here lying on the north side of the head of Indian Creek for transporting 20 persons to the colony, including Thomas Mann.³
- Abt 1660 Nansemond Co., VA. Charles Mann was born to Thomas Mann, Sr., & Elizabeth. Charles never married apparently. When his father gave him 200 acres in 1681 the deed stipulated that if Charles died without issue, the land reverted to the heirs of Thomas Mann, Sr. (Will & Deed Book 1, pp. 473-474). Apparently, this was the land that Thomas Mann, Jr., sold 23 Feb 1690.
- Abt 1666 Nansemond Co., VA. Thomas Mann, Jr., was born to Thomas Mann, Sr., & Elizabeth.
- Abt 1670 Nansemond Co., VA. Unknown daughter was born to Thomas Mann, Sr., & Elizabeth. She married a man named Crawford and had a son William Crawford, according to her brother Thomas's 1735 will, below. The birth date here is arbitrary.
- Abt 1673 Nansemond Co., VA. Sarah Mann was born to Thomas Mann, Sr., & Elizabeth. Birth date is only a guess, based on her marriage by 1693.⁵
- 20 Apr 1680 **Isle of Wight Co., VA. Richard Booth** obtained a patent of 550 acres on Corowaugh Swamp for transporting 12 persons.⁶
- 08 Nov 1681 **Isle of Wight Co., VA. Richard Booth** assigned his interest in this land to **Thomas Mann** and **wife Elizabeth**. Wit.: **John Rogers, Charles Mann**. The deed was corrected on 9 Feb 1692/3. 8

- 08 Nov 1681 **Isle of Wight Co., VA. Richard Booth** also sold 100 acres on Beaver Dam Swamp to **John Rogers**, husband of **Mary Rogers**, sister of Richard Booth. He gave an additional 100 acres adjacent to Mary the next day.
- 08 Nov 1681 **Isle of Wight Co., VA. Thomas Man** of Nansemond and **Eliz.** his wife give to their son **Charles Man** 20 acres in Lower Parish. 10
- 22 Sep 1682 **Isle of Wight Co., VA. Henry Chichley** granted to **Thomas Mann** 300 acres in I. of W. on Chowan River for trans. 6 persons. 11
- 1683 Isle of Wight Co., VA. Thomas Mann and wife Eliz. for 2050 lbs. of tbco. sell to Theophilus Joyner 150 acres on Blackwater River, part of a pat. of 300 acres granted 26 Sep 1682, adj.
 Wm. Mayo and Bridgemen Joyner. Wit.: Wm. Mayo, Rich. Booth. Thomas Mann signed his own name, indicating that he had received some education.

NOTE: William Marion Mann, Jr., speculated that the number of interactions between Richard Booth and Thomas Mann, Sr., and wife Elizabeth indicated that Elizabeth was Richard's sister. ¹⁴

- 07 Feb 1690 Isle of Wight Co., VA. Thomas (X) Man of I. of W. sells to Henry Hearne of Nansemond 100 acres on Corowaugh Swamp adj. James Johnson. Teste: James (X) Bryan, Bridgeman Joyner, James Benn. 15
- abt Feb 1690 **Isle of Wight Co., VA. Thomas Mann** died. His estate was appraised by **William Duck, John Watkins, Robert Johnson**. 16
- 23 Feb 1690 **Isle of Wight Co., VA.** A grant to **Hodges Council**, the younger, by **Thomas Mann** [Jr.] of 200 acres. These assign to **Wm. Kerle** 09 Sep 1692.¹⁷
- 09 Feb 1692/3 **Isle of Wight Co., VA. Richard Booth** had sold his pat. of 550 acres to **Thomas Man** and wife **Eliz.** on 20 Apr 1680 in interest of **John Rogers** and **Charles Man** and made a correction in that document on this later date. ¹⁸
